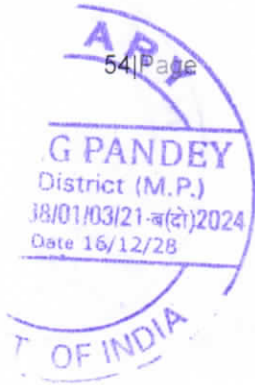
- 8 That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.

APPENDIX-IV

- 12 That the school will follow the provisions related to fee contained in affiliation by-laws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the head of the fee.

- 14 That the school shall strive to make efforts for conservation of environment.
